

Fitness Australia Exercise Professional Registration Program

The Fitness Australia Register of Exercise Professionals (REPs) is a register which recognises the qualifications, expertise and experience of fitness instructors and personal trainers in Australia.

Fitness Australia governs and administers the National Exercise Professional Registration Scheme. The aim of the scheme is to safeguard the health and interests of people using the services of exercise professionals and to provide a system of regulation for exercise professionals to ensure that they meet fitness industry standards and best practice in the Australian health and fitness industry.

Fitness Australia's REPs provides assurance and confidence to consumers, employers and allied health professionals that all registered exercise professionals are qualified and have the knowledge, skills and competence to perform specific roles. Fitness Australia Registered exercise professionals are acknowledged for their professionalism, adherence to industry standards, compliance with the Fitness Australia Code of Ethics and Conduct and commitment to ongoing professional development.

Registering as an exercise professional is more than just a badge to enhance an individuals professional credentials.

To register for the first time, simply follow these steps:

1. Successfully complete your Fitness Qualification or Exercise Science Degree or Human Movement Degree (send in certified copies of your transcript of results or list of competencies for your qualifications).
2. Hold a Current Senior First Aid and Cardiopulmonary Resuscitation (CPR) Certificate (CPR to be completed annually).
3. Complete and pay your registration fee of \$220 inc GST. Registration investment: \$187 inc GST for Two (2) years registration plus Industry Innovation Fund Contribution: \$33 inc GST.
4. Register Now! Register online at fitness.org.au/professionalregistration or complete the application form on the opposite side and return to Fitness Australia along with copies of the above documents via Post: PO Box 6453 Alexandria NSW 2015 or Fax: 1300 734 613.
